# Canada's Clean Fuel Regulations

Documentation and attestation guidance for farmers



## What is the Clean Fuel Regulation?

The Clean Fuel Regulation (CFR) is a Government of Canada policy that is expected to increase demand for liquid biofuel use in Canada created from certain crops like canola, corn, soybeans and wheat.

Crops grown by Canadian farmers (referred to as "harvesters" in the CFR) have streamlined eligibility to participate in the CFR through legislative recognition. This means that Canadian farmers are exempt from demonstrating individual compliance with sustainability requirements related to Land Use and Biodiversity (LUB) Criteria.

However, to confirm the eligibility of crops used in the CFR, the origin of the crops must be documented through the supply chain. The CFR uses declarations to ensure feedstocks have originated from Canadian farms. For any crops harvested in 2024 or after, farmers will be asked to sign an attestation when marketing crops destined for the CFR market.

## What to expect when marketing biofuel crops

#### The harvester (farmer) attestation

Grain handlers (e.g., elevators, grain purchasers, etc.) will ask farmers for an attestation that Canadian

- feedstocks are compliant for use in the CFR. The attestation will include the following information:

  1. Confirmation that the crop was grown in Canada and is therefore eligible for the regulatory LUB exemptions and provisions.
- 2. A single set of GPS coordinates representative of the harvested area of the crop. An example could include the farmyard or the location of the bins.
- 3. An acknowledgment that the farmer understands that the attestation may be subject to third-party verification and agrees to retain their copy of the declaration for 10 years.

The attestation can be included in contracts, existing producer declarations, or produced as a standalone declaration.

The agriculture industry has worked with the grain value chain to develop simple and consistent sample attestation language (see p. 2). This sample language is provided as guidance only, and individual grain handlers may adjust.

## Attestation frequency

An attestation is required a minimum of once per year to cover the crop production for that year. Frequency of signing an attestation may depend on the mechanism that is used (eg: included in contracts versus standalone declaration). that continuously improve nutrient use.

#### **Audits**

Under the CFR, documentation may be subject to audits, including the attestation, with third-party verifiers confirming information such as the harvest location within Canada and corresponding eligibility with the LUB exemptions.

Therefore, it is important that farmers retain a copy of the documentation that contains the attestation for 10 years.
